## **Warranty**

### **A 1-year limited warranty**

The limited warranty set forth below is given by Aodelan Co. with respect to Aodelan flash units, flash heads and flash triggers (the "Product") \*. The Product purchased with this limited warranty is the only Aodelan flash unit, flash head and flash trigger to which this limited warranty applies.

Aodelan Co. warrants to the original end-user purchaser, when delivered in new condition in its original container, that the Product will be free from defects in materials and workmanship under normal use and service for a period of one (1) year from the date of original purchase. Product returned to an Aodelan repair facility and proven to be defective upon inspection will, at Aodelan's sole discretion and without charge, be (a) repaired utilizing new, remanufactured, repaired and/or recycled parts; (b) exchanged for a new Product or; (c) exchanged for a refurbished Product, as determined by the Aodelan repair facility. Warranty exchange or replacement does not extend the original warranty period of the Product.

### **THIS WARRANTY DOES NOT COVER ANY ACCESSORIES.**

This limited warranty covers all defects encountered in normal use of the Product, and does not cover:

- (a) Loss of or damage to the Product due to abuse, mishandling, improper packaging by you, alteration, accident, electrical current fluctuations, failure to follow operating, maintenance or environmental instructions prescribed in Aodelan's user's manual or services performed by someone other than Aodelan Co., or a Aodelan authorized service provider for the Product. Without limiting the foregoing, water damage, sand/corrosion damage, battery leakage, dropping the Product, scratches, abrasions or damage to the Product or damage to the any of the accessories mentioned in the first paragraph above will be presumed to have resulted from misuse, abuse or failure to operate the Product as set forth in the operating instructions.
- (b) Any consumables or accessories, such as for example batteries, modeling lights, cables and flash tubes.
- (c) Parts made of glass, such as lamps and glass covers.
- (d) Use of parts or supplies (other than those sold by Aodelan Co.) that cause damage to the Product.
- (e) If the Product has had its serial number or dating altered or removed.

No implied warranty, including any implied warranty of merchantability or fitness for a particular purpose, applies to the products after the applicable period of the express limited warranty stated above, and no other express warranty or guaranty, except as mentioned above, given by any person or entity with respect to the products shall bind Aodelan Co.. (Some states and provinces do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.) Aodelan Co. shall not be liable for loss of revenues or profits, inconvenience, expense for substitute equipment or service, storage charges, loss or corruption of data, or any other special, incidental or consequential damages caused by the use or misuse of, or inability to use, the products, regardless of the legal theory on which the claim is based, and even if Aodelan Co. has been advised of the possibility of such damages. In no event shall recovery of any kind against Aodelan Co. be greater in amount than the purchase price of the products sold by Aodelan Co. and causing the alleged damage. Without limiting the foregoing, you assume all risk and liability for loss, damage or injury to you and your property and to others and their property arising out of use or misuse of, or inability to use, the products not caused directly by the negligence of Aodelan Co.. (Some states and provinces do not allow the exclusion or limitation of incidental or consequential damages, so the above exclusion or limitation may not apply to you.) This limited warranty shall not extend to anyone other than the original purchaser of the products, or the person for whom it was purchased as a gift, and states your exclusive remedy.

It is your responsibility to properly package and send the defective Product, together with a copy of your dated proof of purchase, a complete explanation of the problem and a return address to the authorized service center at your expense. Do not include any other items with the defective Product. The Product covered by this limited warranty and proven to be defective upon inspection will be repaired and returned to you without charge by the authorized service center. Any Product received by the authorized service center that is not covered by the limited warranty will be returned unrepai red, or at the discretion of the authorized service provider, you may receive a written estimate of repair at such cost as the service center may establish from time to time.

### **Consumer legislation**

Consumers covered by mandatory consumer protection legislation or the equivalent in the country where they reside will enjoy the benefits this Limited Warranty confers in addition to their consumer rights as governed by local or national law. Some countries, states and areas do not permit non-acceptance or limitation of liability for indirect damage or resulting damage or non-acceptance of or limitation of the period of liability relating to implied warranties or conditions, in which case, the above may not apply to certain end-users. This Limited Warranty gives the end-user certain rights, but the end-user may also have other rights depending on country, state or area.
